- **Street Lights**-We met with Edison yesterday and the remaining streetlights uptown will be installed soon.
- Strawser Crack Sealing- The following areas have been identified for crack sealing in 2018: Brentwood, Brubaker, Busdeker Lane, Elise Lane, W. Evans, Gibson St, W Kemmerling, Lime, Linden, Luther Lane, Meadow, Ohio, W. Yeasting. In all, it adds up to 74,884 square yards. Cracks will be blown out and swept prior to the sealing.
- **September 11th Ceremony-**We are in the process of finalizing the agenda for the event which will take place on Tuesday, September 11th at 7:00pm in Williams Park. More information to come.
- **Traffic Light-** We will be receiving funds in the amount of \$9,133.00 for the claim settlement for the damage to the traffic light and traffic control box last January. I would suggest that follow the recommendation of Miller Line and Cable and replace the control system and apply these funds towards that cost.

Police Chief- Whitaker- provided a sheet of flex hours and diversion hours.


