Mayor's Report:

Congressman Jim Jordan was here Friday 6/12/20 to Review how village was handling all issues.

Administrator's Report:

- CARES Act Funding- We have spoken at past meetings about the CARES Act and funding availabilities for "non budgeted COVID 19 expenditures." The State finalized the process and the allocations available to each county and each municipality at the end of last week. One of the requirements to utilize any of the funds designated for Gibsonburg is the passage of a resolution that ensures that the Village agrees to the format of the process. With the passage of the resolution, we are able to draw on funds for non budgeted expenditures. Sandusky County has \$2,117,639.31 allocated for all municipalities and of that amount \$69,589.82 is directly earmarked for the Village of Gibsonburg. We are working on an itemized list of non budgeted expenses related to COVID 19 that will be submitted for reimbursement.
- Storm Event June 10th- There was no major damage from last weeks storm that came through. Quite a bit of downed limbs throughout the town and once tree in Williams Park that ended up having to be removed completely due to damage. Once again, the staff responded quickly and worked all day Thursday and Friday on cleaning up the town. Huge thanks to Kemp, Paul, Rob and Matt for all of their efforts.
- Rail Crossings- Last week we received notice from the Public Utilities Commission of Ohio that they have directed the Northern Ohio & Western Railroad (NOWR) to upgrade all warning devices at the six grade crossings in the Village of Gibsonburg. These include: SR 300/S Main St, W. Stevenson St, SR 600/W Madison St, W. Yeasting St, W. Kemmerling St and W. Stone St. Upgrades include minor roadway work if necessary. In total, this is a \$1,164,687.00 investment into the Gibsonburg community with the cost being shared by the Sandusky County-Seneca County-City of Tiffin Port Authority, Public Utilities Commission of Ohio and the Ohio Rail Development Commission. We sincerely thank all three groups for their willingness to have discussions with us to understand the issues that exist with the crossings in the Village of Gibsonburg and their investment in our community. The project has a December 3, 2021 completion date.
- Alley Work- Contrary to social media reports, we have been working on alleys. Storm clean up last week interrupted the process, but we are working on them, including rolling them after grading and adding any needed material to them. We will continue until they are done, but please keep in mind that when issues arise such as storms or water breaks, we have no choice but to stop working on alleys and pay attention to those issues. We did end up starting on the west end instead of the east and apologize for any confusion.
- **Ohio EPA Water Shut Off Order-** The EPA has revoked/terminated the order put out March 31 2020 that prevented any water shut offs for non-payment from occurring. This will take effect on July 10, 2020.
- Playgrounds- All playgrounds and basketball courts are open to the public.
- Public Nuisance Code- We have spoken with the property owners at 408 W Stone and 613 E Madison and are working to resolve the issues. No response has been received as of yet for 500 E Yeasting, 628 W Madison. We will revisit all of the properties cited on Monday.
- Linden Avenue Paving Project- The project has been 100% completed.
